Kerala State Higher Education Council (KSHEC), is an apex level statutory body constituted under the Kerala State Higher Education Council Act, 2007 of the State Legislature. Currently, the Council is piloting a project named Prabudhata, in Karakulam Grama Panchayath, Thiruvananthapuram with the aim of developing a replicable model for democratizing knowledge produced/ handled by Institutions of Higher Education/knowledge.

Applications are invited from suitable candidates for engaging as the **Facilitator** of the above project. Details are shown below:

Name of the Post: Project Facilitator-Prabudhata

Mode of Engagement: Contract; (Till the completion of the project or 1 year, whichever is earlier)

Qualification & Experience: MSW/MA in Sociology. Candidates with research experience will be preferred.

Age Limit & Relaxation:-Not more than 40 years as on 01.06.2018. A relaxation up to 5 years will be provided in age limit to candidates belonging to SC/ST/PWD.

Duties and Responsibilities: - Field level involvement and coordination for the successful implementation of the Prabudhata project. Documentation of the process of implementation.

Consolidated Monthly Remuneration: - Rs.33,925/-

Application Format: - A format of the application is attached to this notification. However, applicants are free to prepare their own applications without omitting the requirements demanded in the format.

Write up: The application shall be accompanied with a write up on the following theme:

“I am confident that I can facilitate the field level implementation of a community based participatory project”. Why? (Approximately 300 words).

Enclosures: - Self attested copies of documents to prove Identity, Address, Age, Religion and Caste, Qualifications, Experience etc.
