Prof. Madhusoodanan, Vice Chancellor, CUSAT informed his inability to attend the meeting on account of the Syndicate meeting.

**Decisions**

Prof. Rajan Gurukkal, Chairman, SLAC in his introductory speech emphasised the need for resolving the issues related to equivalency/ recognition of degrees based on the directions of the Hon'ble Chancellor/ UGC directives/ Handbook of Equivalency published by KSHEC/ GO issued by the Government in this regard.

**Resolution on issues related to equivalency.**

After detailed discussion it was unanimously resolved to require the universities to scrap the practice of requiring the candidates to produce the equivalency certificate for the degree from other universities for securing admission to academic programmes or appointment.

It was further resolved to advise the Government to amend the special rules accordingly so that the PSC will not have to demand the equivalency certificate from the candidate. PSC in turn is advised not to insist upon the equivalency certificate from candidates qualified in the test and interview.

It was also recommended to dispense with the practice of insisting on equivalence certificate for continuing higher education, where admission is secured through entrance test.

It was also resolved to recommend that the Degrees/ Diploma/ Certificates awarded for programmes conducted by the ODL institutions recognised by DEC (erstwhile) and UGC, in conformity with UGC Notification on specification of Degrees should be treated as equivalent to the corresponding awards of the Degree/ Diploma/ Certificate of the traditional Universities/ institutions in the country.
