### The following agenda was transacted and decisions taken.

#### Item No. 1. Study in Kerala and Higher Education Conclave.

The following decisions pertaining to Study in Kerala initiative and Higher Education Conclave were taken.

- a) Resolved to implement the Study in Kerala Programme in two phases. In the first phase, the programe should focus on attracting foreign students for short term programmes offered by universities/ colleges in the state. In the second phase full time programmes offered by select Universities and colleges may be offered to international students.
- b) A single window system in universities may be created exclusively for international students to lessen the existing administrative delay related to admission, examination including viva voce, and issuance of degree certificates.
- c) In addition to international hostels, the possibility of enlisting local agencies including vacant houses in and around the universities may be explored For providing accommodation for international students.
- d) University websites should be revamped, highlighting the unique nature of programmes offered and the level of ranking and accreditation of the university.
- e) One semester/double degree/ joint degree programme/ special programmes involving experiential learning and scholarly lectures for international students may be designed by universities/ colleges.
- f) Indian Council for Cultural Relations (ICCR) may be actively involved in the "Study in Kerala initiative"
- g) The Erudite -Scholar in Residence programme, memorandum (MoU) of understanding signed by universities and faculty participation in international conferences may be utilized for developing international academic linkages.
- h) Universities/ colleges may be involved actively in the organization of Higher Education Conclave including mobilization of financial resources and inviting international scholars to the programme.

i) A brochure / a suitable Flyer template may be designed for showcasing the academic and cultural strength of state universities.

#### Item No. 2. Centres of Excellence.

Kerala State Higher Education Council has submitted a proposal seeking Administrative Sanction for the establishment of Centres of Excellence at total estimate cost of Rs. 11,40,00,000 (Eleven Crore Forty Lakh) by meeting the expenditure from the provision under the head of account 2202-03-103-48-00-00-P-V. The Working Group Meeting held on 06/06/2024 has decided to establish the Centres of Excellence as proposed.

The Government have examined the matter in detail and accorded Administrative Sanction for the establishment of Centres of Excellence at total estimate cost of Rs. 11,40,00,000 (Eleven Crore Forty Lakh), with the following component, by meeting the expenditure from the provision under the head of account 2202-03-103-48-00-00-0-P-V.

# Item No. 3. Utilising the annual interest on Corpus fund for Higher Education Scholarship.

As per the approved Guidelines of the Higher Education Scholarships, scholarships are awarded from the year 2010-11, by utilizing the annual interest on the corpus fund collected by the Council and grant-in-aid provided by the Government.

The Accountant General in its audit observation (Letter No. AMG II (HQ) IV/1/10- 181/2018-19/26 dated 8/05/2024) referred to idling of funds amounting to Rs. 6.83 crore accrued byway of interest of the Higher Education Scholarship Corpus fund.

#### **Detailed statement of Funds.**

- 1. **Scholarship Corpus Fund (i)** Consists of the principal amount of Rs. 4 crore (3 crore Govt. contribution +1 crore public contribution) and it has accrued interest of Rs. 6, 12, 24,979/- (after deducting TDS) over the years from 2011 onwards and now it is deposited in the District Treasury, Thiruvananthapuram as fixed deposit amounting to Rs. 10, 12, 84,979/- on 21.02.2024 for 25 months for an interest @ 7.5%. (Maturity date 21.03.2026).
- Scholarship Corpus Fund (ii) Consists of the principal amount of Rs. 20 lakh (public contribution) and has accrued interest of 11, 16,302/- from the year 2016 onwards.
   Now it is deposited in District Treasury, Thiruvananthapuram as fixed deposit of Rs. 31, 39,342/- w.e.f. 25.06.2022 and 25.07.2024.

Based on the Higher Education Scholarship Guidelines and observation of Accountant General (AG), it was resolved to utilize the accrued interest on corpus fund (I&II) for disbursing Higher Education Scholarship for the year 2024-25 as detailed below.

# Item No. 4. Transition of existing students in CBCSS/FYIMP to FYUGP – reg.

After detailed discussion it was resolved to recommend to the government to permit the transition of existing students pursuing Five-Year Integrated Master's Programme (FYIMP) in the Kannur University (prior to 2024-25 admission) to Four Year Under Graduate Programe (FYUGP) with the following conditions.

- a. Suitable amendment in the FYIMP Regulations of the Kannur University facilitating the transition of existing students in FYIMP.
- b. UGC directives on March 2024 (Ref. No. 60-1 (QTP/Misc.) t2024 01 March,2024/1) which permit students to take additional courses (including online courses) to fulfil the mandatory requirements to enable transition to FYUGP shall be followed. The existing FYIMP students may be permitted to take additional DSC courses from other Departments as per their choice to earn the required credits under new curriculum frame work.
- c. The transition of existing students in FYIMP to the new Regulation shall not create any additional financial liability.

The above matter is submitted to the Government of necessary action.

#### Item No. 5. Report on common norms for Grace Mark.

Resolved to finalise the recommendations on common norms for Grace Mark and forward the same to the Government.

### Recommendation of the committee for grace marks under FYUGP

1. Flexibility in choice: In the Four Year Undergraduate Programmes (FYUGP) students can be granted flexibility to opt for either marks or credits for their performance and achievements and credits for participation in sports activities including coaching camps at national, State, university or college level.

# 2. Awarding Credits for Performance, Achievements and Participation

The following are the eligible activities recommended by the Committee for availing credits under the FYUGP.

### 2.1 Credits for exceptional athletic achievements (SPEAA)

Students qualifying and representing the nation in Olympics, Asian Games, Commonwealth Games, may be entitled to receive 52 credits directly (approximately 39% of the total credits required for getting a 3 year UG degree) Out of this 52 credits, 32 credits can be used for their major/minor credits as per their choice and the remaining 20 credits can be used for the Foundation Courses including internship (except AEC). By doing this, if students could not receive 50% of credits from their discipline required to qualify for a major, then they can be awarded General BA, BSC, BCom degree, as per the FYUGP Regulation.

# 2.2 Credits for Participation in National, State, University and Sports Camps: (SPNCA)

Students participating in coaching camps conducted by Universities, State Associations, or National Federations can earn academic credits for their involvement in the above categories of Coaching Camps, provided prior sanction is obtained from the Director of Physical Education of the concerned university in case of the final National Camp and the final State team camp through the Head of Physical Education & Principal of the College. These credits are awarded based on verified participation and can be applied to any Value-Added Course (VAC) Upon earning 3 credits, students are deemed to have passed the VAC.

Students may be given a provision to earn additional credits for their structured training programmes based on their performance evaluation by the competent authority. These can be considered in line with short term vocational training courses and a maximum of 12 credits can be exempted in the FYUGP based on the credits

For awarding the credits, the student shall forward a statement of the total hours of engagement/ training duly signed by the Director of Sports of the University in case of University Camps, the Secretary/ Head Coach of State Association / National Federations in case of State camps/ National Camps to the Head of the Institution. Credits shall be calculated as follows. (Total Hours Involved) 60 Hrs. This system promotes active participation in sports, recognizing and integrating students' athletic efforts into their academic achievements, thereby supporting a holistic educational experience.

# 2.3. Award of Credits for Sports Activities at College Level (SPAC)

To promote physical fitness and to encourage participation in sports activities among students, it is proposed to institute a credit-based system for involvement in sports, Yoga, and Physical programs. The following guidelines outline the process for acquiring and awarding credits through participation in these activities: -

All students are eligible to participate in sports activities, fitness drives, Yoga, and Physical Programs conducted by the college. Participation must be officially recorded and verified by Faculty of the Department of Physical Education or program supervisor. Students who shall complete the prescribed sports activities with at least 180 hrs of regular participation during their FYUG programme will be awarded 3 credits and can be exempted from one Value Added Course (VAC).

# 2.4 Award of Credits for participation in NSS activities in College Level

Students who complete minimum regular activities of 240 hours including one Special camp (7 days) will be awarded 3 credits and can be exempted from one Value Added Course (VAC). This must be officially recorded by the Programme Officer of NSS Unit in the College.

# 2.5 Award of Credits for participation in NCC activities in the College Level

Students who participate in the prescribed NCC activities with 75%attendance or above in 3years will be awarded 3 credits and can be exempted from one Value Added Course (VAC). The details of the activities must be recorded by the Faculty in Charge of NCC unit in the colleges.

# 2.6 Award of credits for other eligible participations in the college level

Respective universities may decide other eligible participations at the college level such as participation in 'Earn While You Learn' (EWYL) scheme, services during natural disaster, entrepreneurship, start ups or any other activity deemed to be fit for awarding credits.

Students can claim only one activity during a Programme for claiming the credits for availing exemption from the Value – Added Course (VAC).

# 2.7 NCC as an elective subject in FYUG Programme

Based on the letter D.O.No1-18/2019 (CPP-II) dated April 2021 from UGC, NCC can be included as an elective subject and can be awarded a maximum of 24 credits. Based on this NCC Directorate has submitted a request for inclusion of NCC as an elective credit course in FYUG programs in all semesters. Universities may consider this and can include NCC as a vocational minor subject in FYUG programmes and can provide a maximum of 24 credits as per their activities. If the students opt NCC as their vocational minor, then they are not eligible for the grace marks or any other credit exemption

#### 3.0 Awarding Grace Marks for achievements and performance

Grace marks shall be awarded for performance/ achievements in sports and games, youth festivals, NCC and NSS activities in the Four-Year Undergraduate (FYUG) program to recognize and reward students who excel in these areas. These marks encourage holistic balancing of

academic and co-curricular commitments. Grace marks is an additional incentive for certain achievements and performance.

# 3.1 Grace marks for sports performance

Sports Grace Marks shall be limited to events included in the Annual Sports Calendar of the respective Universities. The grace Marks for each performance of an athlete at different levels in different competitions will be cumulatively added annually. Grace marks can be accumulated up to a maximum of 25% per annum while credits can be accumulated to a maximum of 25 % of the total required credit per semester (if the students opt to choose credits instead of grace marks)

The grace Marks for each performance of an athlete at different levels in different competitions will be cumulatively added annually. Grace marks can be accumulated up to a maximum of 20% per annum while credits can be accumulated to a maximum of 20% of the total required credit per semester (if the students opt to choose credits instead of grace marks)

#### 4.0 General conditions

# 4.1 Application Process:

Students are required to apply for grace marks/credits during the respective academic year. Once approved, these marks/credits shall be deposited in a designated grace credit/mark bank. The application for grace marks/credits will be processed at the end of the 6th semester and can be applied to any subjects across the six semesters to the benefit of the students. For students opting to continue for the Honours program, eligible grace marks for the 7<sup>th</sup> and 8<sup>th</sup> Semester shall be effected at the end of the 8<sup>th</sup> Semester.

#### 4.2 Equal Distribution:

Eligible grace marks/credits shall be evenly distributed across all papers/courses of an examination, ensuring fairness and equity in their application.

**4.3. Redistribution Clause**: Redistribution of grace marks/credits is permissible only for papers in which the candidate has already passed. This redistribution may only occur from a passed paper to a failed paper, regardless of the semester/year. The grace mark is distributed

in the best interest of the student while redistributing Grace Marks. Grace marks/credits shall be awarded for regular examinations and can also be granted for the next two immediate chances of supplementary examinations.

#### 4.4. Online Mechanisms for Grace Mark in Universities

In order to lessen the problem related to award of Grace Mark to students, Universities shall develop suitable online mechanisms, for uploading details of GM from colleges to the universities (similar to the online facility existing for uploading of internal marks). This will help the timely award of Grace Mark and declaration of results of students.

# Item No. 6. Appointment of BBA Assistant Professors – Qualification and Ratio.

Resolved to adhere to the earlier recommendations in this regard. It was also decided to incorporate details of AICTE Regulations related to pay scales, service conditions and minimum qualifications for appointment of teachers and..... in technical institutions and measures for the maintenance of standards in Technical Education (Degree) Regulation 2019 as BBA programme has been brought under the purview of AICTE.

#### **Recommendations of the Committee**

The commerce content as well as the commerce workload in the BBA syllabus should be specified as is done by other Universities. This need be done by a panel of experts from outside Calicut University.

- 1. Bifurcate the Commerce and Business administration departments in all colleges where both BBA and B Com programmes are offered. Bifurcation does not create additional posts, instead, reduce the number of permanent faculty.
- 2. Allow Commerce faculty members, who are working on BBA workload as Assistant professor/Associate professor/Professor to continue until they retire from service. Appointment to such positions after the retirement of present incumbents should be from MBA plus NET/PhD qualified candidates.

# Item No. 7. Centre for E-Learning and E-Content Development.

Resolved to constitute a sub committee under the chairmanship of Prof. Saji Gopinath (Vice Chancellor, Digital University of Kerala) and experts from universities to work out the details of establishing a state level digital platform for e-learning and e-content development.

#### Item No. 8. Internship Policy: Guidelines & Procedures.

Resolved to form a separate online portal for Internship/ Research Internship for Undergraduate Students and develop detailed guidelines and procedure in this regard with the active involvement of public institutions in this area.

#### Item No. 9. State Level Vocational and Skill Development Cell (VSDC).

Resolved to authorize the Vice Chairman to constitute an expert committee to examine the proposals submitted for empanelment by various skill agencies.

#### A1. Regarding the conduct of exams in FYUGP

As directed by the Government, it was resolved to organise university wise training/workshop to members of various Board of Studies (BoS) to form OBE based question bank using Artificial Intelligence (OGI AI).

# A2. Draft Report on Starting Diploma Course in Fine Arts in Affiliated Colleges, Kannur University

Approved the recommendations submitted and resolved to reject the request for permission for Starting Diploma Course in Fine Arts in Affiliated Colleges under Kannur University as there are several reputed / accredited Fine Arts colleges/institutions offering degree and diploma courses in the state.
