Empanelling of eligible Professional Skill Training Agencies for providing support for the establishment and operation Centre for Skill Development Courses and Career (CSDCCP) Planning in the Higher Education Institutions (HEIs) in Kerala (Ref1: G.O. Rt. No. 724/HEDN Dated, 24.06.2024)

As per the government order read as ref 1, the government has entrusted the Kerala State Higher Education Council to identify and recommend for empanelling the eligible agencies for providing the required operational support for the proposed Centres for Skill Development Courses and Career Planning (CSDCCP) to be established in the Higher Education Institutions (HEIs) in the context of the Implementation of Four Year Undergraduate Programmes (FYUGP in State Universities and Colleges.

Accordingly, proposals are being invited from reputed agencies/ industries/corporations/companies that are interested in providing suitable support for the establishment and operation for the proposed Centre for Skill Development Courses and Career Planning (CSDCCP) in the Higher Education Institutions in Kerala

- 1. The details of the courses that are being proposed by the agency shall include the Course Overview with its NSQF level, job role, learning outcomes, course content, assessment criteria, required infrastructure facilities for offering the course, notional learning/training hours, entry qualification for the course.
- 2. The proposed courses shall be of credit-linked short-term skill development certificate courses of 3-6 months duration with an NSQF level 4.5 or above with a minimum credit of 12 and a maximum credit of 30.
- 3. The curriculum proposed for these courses shall be aligned with Qualification Packs (QPs)/ National Occupational Standards (NOSs) of selected job role(s) within the industry sector(s).
- 4. The curriculum developed by the concerned Sector Skill Councils, wherever available, may be adopted or adapted in consultation with the industry partners. If the curriculum is not available, the same may be developed in consultation with the relevant Sector Skill Councils and industry partners.
- 5. The certificate for skilling component would be awarded by the Sector Skill Council in terms of NSQF level either singly or jointly with the institution concerned.
