## FOREWORD

The Government of Kerala constituted the third Council on November 7, 2017 after the promulgation of the Kerala State Higher Education Council (Amendment), Ordinance 2017. The amendment of the Council Act, in addition to the mandated responsibilities of the Council in higher education in the State, further increased the responsibilities of the Council. It has paved the way to a collaborative role of the Council with the centrally sponsored scheme – RUSA – in higher education. The most significant aspect of the amendment pertains to the formulation of the norms and guidelines for recognition/ equivalency of degrees of different Universities and higher education institutions. Several important committees were constituted during the report period. The committee on Autonomous Colleges, Open University, Inter University Centres and norms and guidelines on recognition/equivalency have submitted their reports to the government of Kerala. The work of several important committees in the realm of curriculum restructuring, filling up of teaching post, finances of Universities, problem of researchers etc were also constituted. In spite of all the financial difficulties, the Higher Education Scholarship and the Erudite Scholar -in -Residence Programme continue as the flagship programmes of the Council with full government support. It is self-congratulatory to see an annual report of an understaffed institution like the KSHEC, going commendably adhesive to the concepts, objectives, strategies, and activities postulated in its action plan. Since the contents of the Report vouch for it, I do not want to specifically restate any of our achievements by way of justification. I express my sincere gratitude to the Hon. Minister for higher education and officials of the department of higher education and entire staff of the Council for their efforts during the report year.



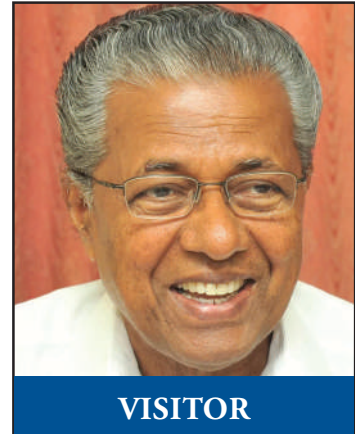

## SETTING UP OF THE COUNCIL

The National Education Policy of 1986 envisioned state level agencies for coordinating educational activities. The Kerala State Higher Education Council is such an agency that came into existence, following the Kerala State Higher Education Council Act (No.22) passed by the State Legislature in 2007. State Higher Education Council was set up in 2000 through an executive order, but it had only a short life. Subsequently in 2003, a chapter on State Council of Higher Education was included in the Unified Universities Bill presented in the State Assembly, but that was never enacted. In 2005, the Government organized a one-day workshop involving Vice-Chancellors, academics and administrators. On the basis of the discussions held at the workshop, a draft Ordinance was prepared, and later turned into a draft Bill. However, this Bill was also not enacted. In 2006, a Higher Education Commission under the Chairmanship of Dr. K.N. Panikkar was appointed for making recommendations to the Government for constituting a Higher Education Council. On the basis of the recommendations submitted by the Commission, the Kerala State Higher Education Council was set up on 16th March 2007 through an Ordinance that became legislated as the Kerala State Higher Education Council Act 2007 (Act 22 of 2007).

Kerala State Higher Education Council Act 2007 was amended through an ordinance by the Government of Kerala on July 2017 (See Appendix I-Full Text of the Ordinance 2017). The major provisions of the amendment are;

- (1) Amendment of the preamble.—In the principal Act, in the preamble, in the first paragraph after the word “experts”, the symbol and the
- (2) word “, students” shall be inserted
- (3) Substitution of certain expressions by certain other expressions.—In the principal Act, for the words “Advisory Council”, “Executive Council” and “Governing Council”, wherever they occur, the words “Advisory Body”, “Executive Body” and “Governing Body” shall respectively be substituted
- (4) collaborate with the Government in the implementation of RUSA and similar centrally sponsored schemes and other central sector schemes within the State;
- (5) evolve common academic guidelines for Universities in the State for mutual recognition, approval or equalization of academic programmes/areas of studies and nomenclature thereof;

- (6) evolve common academic guidelines for Universities in the State for recognition, approval or equalization of academic programmes/ areas of studies and nomenclature thereof of various programmes conducted by Universities or higher education institutions outside the State and outside the country;
  - (7) the Patron may refer any matter relating to higher education and higher educational institutions as he deems fit, for the expert opinion of the Council.”.
  - (8) The Visitor may refer any matter relating to higher education and higher educational institutions, as he deems fit, for the expert opinion of the Council.”.
  - (9) it shall nominate one of its members to ‘the Academic Council of each University’
- The Council plans and executes schemes and programmes that ensure social justice, access and quality in higher education.

## CONSTITUTION OF COUNCIL

The first Kerala State Higher Education Council came into existence on 16 March 2007, with the renowned educationist and historian Dr. K.N. Panikkar as its Vice-Chairman. The tenure of this Council ended on 15 September 2011. Subsequently, the second Higher Education Council, with

Sri. T.P. Srinivasan, the retired Ambassador as the Vice-Chairman, was formed on 12 October 2011. Its term too came to an end on 11 April 2016. The third council with Prof. Rajan Gurukkal Former Vice Chancellor of Mahatma Gandhi University, Kottayam and renowned historian, as Vice Chairman was formed on 7th November 2017.

The Governing Body meeting held on 23/01/2018 resolved to setup a committee of Pro- Vice Chancellors to prepare the details

related to formulation of a common academic and examination calendar for Universities in the State and to monitor University Examinations.

### Decisions of the Pro- Vice Chancellors Meeting held on 26/03/2018

Resolved to formulate common Academic – Examination Calendar for affiliating Universities in the State. It was also resolved to introduce a system of split vacation (November – May) instead of the annual vacation (April

– May) system now prevailing in the affiliated Universities/ Colleges (Kerala, Mahathma Gandhi, Calicut & Kannur Universities). The following details of the above scheme were also agreed upon by the Committee.

#### I. Academic Year:

The Academic year for all Universities/ Colleges affiliated to the University and Educational Institutions and Departments

maintained by the University begins on the 1st June each year and ends on the 31st of May next year.

#### II. Semesters:

1. The academic year shall consist of two semesters of six months duration, as following except for B.Ed Programmes.
2. Duration of odd number semesters (1, 3, 5 etc) shall be June to November every year, for all programmes (UG/PG).
3. Duration of even number semesters (2, 4, 6 etc) shall be December to May, every year,

for all programmes (UG/PG).

4. There shall be one month semester break/ vacation in each semester, in November, and May every year.
5. A period not exceeding 15 days shall be allowed for the Onam & Christmas holidays. The exact days will be notified by the University each year.

#### III. Working days:

1. Each semester consists of a minimum of 450 contact hours distributed over 90 working days, inclusive of examination days, within 18 five-day academic weeks.

2. Provided that it shall be competent for the Syndicate to condone the shortage of attendance in minimum number of working days/hours in appropriate cases, to the extent fixed.

#### IV. Academic and Examination Calendar:

1. First semester UG Admission should be completed after one month of the

publication of the qualifying examination results (Plus two etc).

2. First semester UG classes should commence after two/ three allotments by the Universities through the Single Window Systems of (SWS) admission (CAP etc.)
3. In all circumstances first semester UG classes should commence before June 30th.
4. Detailed examination calendar for all programmes/ semesters should be published in the month of January every year after consultation with teachers'/ students'/ service organizations.
5. A schedule for Centralised Valuation Camps should also be prepared along with the examination calendar.
6. Earned Leave and other benefits, if any, now enjoyed by all staff (Teaching and non-teaching) in the annual vacation pattern (April – May) should be retained in the split vacation (November – May) pattern also. Necessary amendments in the KSR/ KSSR/Statute/Ordinance/ Regulation etc of all affiliating Universities should be made before June 2018.
7. Results of odd semester examinations (1, 3, 5) should be published before December 31st of every year.
8. Results of even semester examinations (2, 4, 6) should be published before June 30th of every year.
9. Separate examinations calendar for private registration/SDE stream should also be published.
10. Approval of teachers in the Self Financing Colleges/programmes should be made mandatory by the university to ensure quality of teaching/ examinations and availability of teachers in the CV Camps.

## Academic Divisions of the Council

Activities of the Council fall under its three main Centers viz:

- (a) Centre for Research on Policies in Higher Education,
- (b) Centre for Curriculum Development and Examination, and
- (c) Centre for Human Resources Development and Capacity Building.

Each Centre's activities are summarized below:

### A. Centre for Research on Policies in Higher Education

#### **i) Advice to the government**

The Kerala State Higher Education Council provides advice on policy matters to the Government in general and on specific issues referred to the Council by the Government. During

the report year the Council provided a detailed **Perspective Plan for Engineering Colleges in the State.**

## ii) Library

The library of the Council is a specialized one mainly related with resources on higher education. The library maintains a collection of books, reports of the various committees constituted by the Council and newspaper

clippings related to matters on Kerala State Higher Education Council and other news related to higher education. The Council has purchased 112 books on higher education during the financial year 2017-18.

## iii) National Seminar and Conferences Higher Education Conference

The conference on 'Higher Education problems' organised by the Kerala State Higher Education Council on 5th March 2018 passed the following resolution on the issuance of Equivalency/ Recognition Certificate by State Universities.

*The conference on Higher Education Problems organised by KSHEC on March 5th 2018, has resolved to intimate all Universities / Higher Education Institutions / Public Service Commission and other employers that there is no need of Equivalency/ Recognition certificates for Degrees / Academic programmes of any specific nomenclature for giving appointment / admissions. Other methods of asserting the credibility of Programmes / Degrees such as reference to the list of Association of Indian Universities (AIU) / Association of commonwealth Universities (ACU) and International Association of Universities (IAU) may be followed. Universities should notify and periodically update nomenclatures of corresponding academic programmes and treat them as alternative names for the same. Nomenclature of the Academic Programme/ Degree should not be used for determining eligibility for teaching post.*

The Governing Body of the Council has already constituted a committee to frame Norms / Guidelines for issuance of Equivalence

/ Recognition Certificates by State Universities.

The Publishers of the Journal, SAGE has expressed the hope that Higher Education for the Future may in future be listed in other international data bases as well, if it could be published without break.

Deepika Lakshman, Documentation officer of the Council is coordinating all the activities related to the publication of the Journal. ## B. Centre for Curriculum Development and Examination Reforms

The major initiatives undertaken by the council through Centre for Curriculum Development and Examination Reforms during 2017-18 includes

### 1) Daishanik Paryavaran (Learner Ecosystem Campuses)

Dhaishanik Paryavaran or Learner Ecosystem Campus is a programme with a mission to reconstruct higher education campuses as live organic fields of knowledge acquisition. The scheme purports to transform the present teacher centred higher education institutions into student centred learning environs that encourage creativity and critical aptitude. The Council will take up the responsibility of developing a campus into such a learner ecosystem campus which can be taken as a model and copied by other institutions with necessary changes.

Lerner Ecosystem campuses are expected to give

priority to digital teaching, learning ecosystem and cross-disciplinary dialogues. Such campuses would take the lead in seriously debating and discussing issues concerning drinking water, waste, environmental pollution, global warming etc. which are current issues as well as those threats, challenges and conundrums that are evolving. To facilitate such an ambience, the KSHEC will provide directions and encouragement for interdisciplinary activities and formation of teacher-student collectives on campuses. Discussions are underway with various stakeholders including teachers, students and administrators of the campus.

### 2) Workshops

#### (i) Redesigning of Courses for Outcome Based Education (OBE)

As the UGC has made it mandatory for us to follow the system of Choice Based Course (CBC) and Outcome Based Education (OBE), our UG courses with fairly well updated contents have been under choice based credit and semester system. Although their overall standard is quite good, their structure, composition, procedures and credit administration are to be further fine tuned to incorporate the features

of OBE. Courses are well designed instruction packages in specific knowledge fields, with preconceived results that go into the making of the outcome of the Academic Programme. They are scientifically structured with insights of continuity, sequence, and integration, appropriate for effective learning. Workshops are organized in different universities in the state in this direction for the BOS for redesigning the courses at the UG level.

### What is OBE

Designing a Course is part of the science of teaching and learning. It is integral to OBE that insists upon determination of learning outcome as the first step. Precisely drawn outcomes of a Course provide clarity of purpose in teaching/learning. They act as a running thread of quality control across the planning of curriculum, selection of instructional strategies, choice of learning experience, and preparation of tests. Informing learners about the outcome well in advance, OBE enables ongoing concurrent self-assessment of learners for making sure of their progress towards attaining the outcome. It provides them with chances to demand new learning experiences that ensure the same. Since the outcomes are stated, the teachers also get to know the progress and they enjoy the legitimate right to test whether the learners have attained the goal.

KSHEC has conducted 3 workshops for Board of Studies guided by the resource persons Prof. N.J. Rao (CEDT, IISc, Bangalore) and his associate Dr. K. Rajinikanth in Kerala University, Mahatma Gandhi University, CUSAT and Kerala Technological University at various occasions as follows;

## C. Centre for Human Resource Development and Capacity Building

### i) Prabudhatha Scheme (Community Higher Education)

The programme aims to create awareness among the public about how higher knowledge affects and influences their standard of living as well as various aspects of human existence. The scheme postulates that, in a democratic society, everyone has the right to be abreast of the advantages and repercussions of the new discoveries and inventions. The scheme also intends to develop and circulate a multimedia package, capable of explicating for the benefit of the common people the possibilities and implications of research and studies in the field of higher education which include Structural and Functional Genomics, Agro-biotechnology, Synthetic Bio-engineering, Bioinformatics, Bio Pharmacology, Nano-tech sensors, Nano-

transmitters, Brain-Computer interface Devices, Artificial Intelligence, Robotics, etc.

KSHEC will take up the responsibility of holding campaigning activities in connection with “Prabudhatha” throughout the state in collaboration with higher education institutions. Higher Education Institutions will be directed to observe ‘Open Day’ in order to facilitate common people to interact with researchers and understand research activities as well as to enable them to visit laboratories, workshops and museums. The Council will take the initiative to encourage experts in science and technology to participate in the campaigns for the Prabudhatha scheme.

### Prabudhata : A Path Breaking Initiative to Democratize Higher Knowledge

Prabudhata is a revolutionary concept formulated by the Kerala State Higher Education Council and the project is now being piloted in a unique

and daring manner in Karakulam Grama Panchayath of Thiruvananthapuram district.

#### The Concept

All the public sector institutions and organizations producing/ transacting/ handling higher knowledge, including our universities and colleges, are drawing financial resources from the public exchequer. In other words, such institutions and organizations subsist and thrive on tax payers’ toil. What does our higher

knowledge institutions give to the common man in return? Does he have any right or claim over the fruits of higher knowledge? Are the studies and researches happening in our institutions good enough to address the needs, aspirations and apprehensions of the society?



Prabudhata is a concept evolved from such reverberating questions. As a model project Prabudhata aims to make use of the might of local self governments and the potential of Kudumbashree CBOs (Community Based Organizations) to deliver the benefits of higher knowledge to the community and to garner, in return, inputs, themes, thoughts and ideas

### **Partners of Prabudhata:**

Ashinted earlier, State Higher Education Council is piloting Prabudhata Project in Karakulam panchayat with the active support of the Local Self Government of the area, Kudumbashree Mission and Karakulam Grameena Patana

for meaningful research and studies from the society. The project is to be comprehended as a harbinger of a new democratic knowledge culture, which will permeate throughout the country in due course. Or it is to be seen as an eye opener for centres of higher knowledge and our society alike.

Kendram, a vibrant NGO functioning in the panchayat. The aim is to evolve a replicable model for disseminating higher knowledge, its implications and benefits to common man and community at large.

### **Implementation:**

Though the strategy and process are still in evolving phase, the central theme of Prabudhata has already been finalized. The Kerala State Higher Education Council will empower the people of Karakulam to frame and raise questions (knowledge questions- questions based on higher knowledge, each of the higher knowledge centres is producing/transacting/handling) to the higher knowledge centres in and around Thiruvananthapuram city, with the active support and involvement of Kudumbashree Mission, Panchayat Samithi, CDS and NGOs of the area.

A volunteer team would be formed to disseminate project objects and ideals in the community. Besides the Facilitator engaged by the Council, representatives of the grama panchayat, Kudumbashree CBOs, representatives of NGOs & PTA would be there in the volunteer team. Council and Kudumbashree Mission would jointly impart training to the volunteer team. The volunteer team will raise pertinent questions in the community and arouse interest among common people regarding the implication of higher knowledge in their day to day life. Eventually, the community itself would identify and enlist questions which it wants to place before each centre of higher knowledge.

## Communication Strategy:

Following are some of the components incorporated in the communication strategy frame work.

- Prabudhata installations (thinking man) at Karakulam and Palayam campus of the University of Kerala
- Prabudhata Question Boxes (Prabudhata Chodya Petti) at vantage points to collect knowledge questions from the public
- Street Play (Theruvu Natakam) to enact at selected centres of Karakulam
- Prabudhata Kala Jadhha
- Artifacts at prominent places in the panchayat
- Prabudhata Ayalsabhas and Gramasabhas in Karakulam
- Flash mobs in at least 100 centres, involving NSS volunteers
- Opinion leaders first approach to popularize the ideals of the concept
- Direct mailers to MPs, MLAs, Political Leadership, Local Body Chairpersons, University Authorities, Syndicate Members, College Principals, Student Unions , Academics, top officials
- Effective use of social media
- Judicious use of conventional media

## Expected Outcomes:

Even though Prabudhata is now being piloted only in Karakulam Panchayat, its impact and reverberations would be perceptible throughout the state, thank to the cogent communication strategy. Following would be some of the major outcomes of the project.

- New awakening in the community with respect to its right over the fruits of higher knowledge
- Attitudinal change that would occur in academic/scientific community
- Betterment of the life and vocation of common men through knowledge dissemination
- Genesis of a new democratized knowledge culture
- Social audit of the centres of higher knowledge
- New impetus for community oriented knowledge production
- Preparation of kits and means for knowledge dissemination
- Books, pamphlets, brochures etc. produced by centres of higher knowledge to introduce themselves to the society
- New extension activities likely to be launched as aftermaths of Prabudhata
- Adoption of villages by centres of higher knowledge
- Evolvement of a simplified language to introduce higher knowledge to common people



- Social Angle in Research and Knowledge Production (SARK) : a new parameter to assess the efficacy, relevance, worth and usefulness of researches and studies
- Knowledge Dissemination Responsibility (KDR) : a new criterion to gauge the social commitment and extension drive of colleges and other higher education institutions

### Progress of Prabudhata:

2017-18 was more of a formative year of Prabudhata. The vague idea germinated during the first quarter of the year evolved into a brilliant concept and a concrete project by the end of the year. Particulars of the step by step progress of Prabudhata during 2017-18 are given below in bullet points.

- Initial brainstorming meeting held on 3/8/2017 at the board room of the Council (Dr. Rajan Gurukkal, One Member Commission for KSHEC chaired the meeting)
- Briefing of the project to Hon'ble Ministers for Education and Local Self Government.
- Briefing of the project to Principal Secretaries of Higher education and LSGD
- Two rounds of discussions with Executive Director and other officials of Kudumbashree Mission.
- Brainstorming meeting held on 25/8/2017 at the conference hall of KSSTM (the meeting was again chaired by Dr. Rajan Gurukkal. Representatives of various higher education/ knowledge institutions, including University of Kerala, SCTIMST, VSSC, CTCRI, NATPAC etc. participated in the meeting. Dr.B.Ekbal, Member, State Planning Board also participated in the meeting.
- Giving of formal letters to Kudumbashree Mission, Karakulam Grama Panchayat and other stakeholders.
- Meeting with Karakulam Grama Panchayat authorities, Kudumbashree authorities and other well wishers held on 10/1/2018.
- Meeting held on 31/1/2018 at Karakulam grama panchayat to present the concept to the members & officials of the panchayat and CDS office bearers.
- Prabudhata team building seminar held on 21/02/2018 at Gramina Patana Kendram, Karakulam.
- Joint meeting of the opinion leaders Academic/Higher Knowledge bodies and Prabudhata functionaries held on 28/2/2018 at Municipal Guest House, Vazhuthacaud.
- All the meetings of Prabudhata have been videographed as it is a pilot project meant to be replicated elsewhere in future

## 2. Workshop on Computer Interfaced Scientific Experiments

Science experiments generally involve measurement/control of physical parameters like temperature, velocity, acceleration, voltage, current etc. The conventional method is to use a dedicated setup for each experiment. A more economic and flexible approach is to interface these sensor and control elements to a computer and sequence the experiment using software. This also has the added advantage of collecting large amount of experimental data at precise

time intervals, its analysis and display. This is the method followed by research labs all over the world. Educational institutions in India are still following the conventional method, except for some like IISERs and IITs, mainly due to lack of availability of equipment made in India. Such equipment is available from vendors like Pasco, Vernier and PhyWe, but are very expensive.

### Inter-University Accelerator Centre (IUAC)

Accelerator Centre, New Delhi, a particle accelerator lab under UGC, has taken a small step in changing this scenario as a part of their outreach program. Under this program, IUAC develops and promotes computerized lab equipment. The designs are open sourced. \*ExpEYES (Experiments for Young Engineers and Scientists) is a hardware and software framework to implement science experiments in an inexpensive manner. In simple technical terms, ExpEYES is device that can generate/measure analog/digital voltage signals as a function of time. But this basic functionality is enough to make it capable of carrying out the functions of an oscilloscope, voltage source, frequency counter, arbitrary waveform generator etc. A large number of experiments at the undergraduate level have been performed and documented for this. GUI programs are available for a large number of experiments, and new experiments can be developed easily by adding more sensor elements and coding in Python.

A training program on ExpEYES covers a set of experiments that the participants can perform with their own laptops after connecting the device to the USB port. It also covers a little bit of the design details and Python programming so that the participants learn how to develop new experiments in a cost effective and eco-friendly manner. 25 teachers from different colleges/ universities participated in the workshop held from 16 to 18th November 2017.

Dr. Manulal P. Ram, Research Officer of the Council coordinated the Workshop.

Workshop was meant for faculty members of various colleges affiliated with state Universities. Most of the participants belonged to Physics and Electronics discipline although there were a few participants from other science disciplines also have attended. The workshop was fully activity oriented in which ExpEYES kit was being utilised for hands-on experience. In assistance with the technicians from the ICFOSS of Government of Kerala, participants have been provided sufficient training with various experiments of basic physics for UG and PG level. Besides the above said participants, 20 teachers from various engineering colleges of the state have also got a half day training with interface.

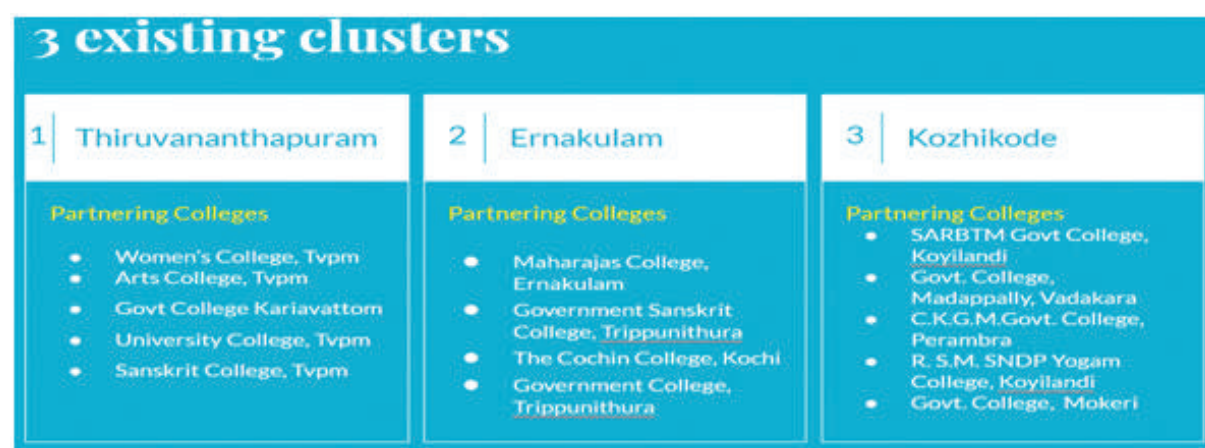

objective. Colleges as a Cluster can perform higher academic functions compared to what each individual College can, and benefits for each institution are larger than the resources that each institution invests. ## Handbook for Cluster of Colleges scheme

The necessity of a handbook for the functions and implementation of Cluster of Colleges has been mooted in various occasions by the member colleges of the existing clusters functioning at Thiruvananthapuram,

Ernakulam and Kozhikode. The purpose of this scheme, its functions, possibilities, proper and justifiable utilization of funds, achieving the long term objectives etc are essentially the primary understanding to be instilled among the colleges.

## Erudite Scheme

Government of Kerala has initiated several steps to improve the quality of higher education and research in the Universities in the State. As a part of this general endeavor, the Government introduced a 'Scholar in Residence Scheme;' called Erudite, to enable the academic community to interact with outstanding scholars and nominated the Council as the

Nodal agency for the implementation of the scheme. This is one of the ongoing project, of the Higher education Council, which is functioning as per the guidelines framed by the Council and is administered with a special fund provided by the Government. In the initial stage, the beneficiaries of the scheme were only University Departments, later it has been



extended to Government and aided Colleges also. Around 220 National and International Scholars, including Nobel laureates, have taken part in various programmes organized by universities and colleges under the Erudite Scheme.

63 Erudite-Scholar in Residence programmes were sanctioned in the finance year 2017-18 out of which 60 were held. (Details are attached herewith). KSHEC directly organized

4 Erudite programmes involving Prof. Romila Thappar, Prof. Prabhath Patnaik, Prof. Utsa Patnaik and Prof. Amit Bhaduri.

An orientation programme on Erudite scheme was organized at University of Calicut on 31.08.2017. Pro Vice Chancellor, Registrar, Deans, Heads of Departments and other senior officials attended the meeting. Sri. Shefeeque V (Research Officer, KSHEC) delivered the Keynote address.

## Higher Education Scholarship Scheme

The very concept of instituting scholarships to meritorious students to pursue higher education was an offshoot of the declared motto of the Kerala State Higher Education Council; that is to bring about equity and excellence in higher education sector. Act 22 of 2007, by which the KSHEC was set up, empowers the council to evolve schemes for providing equitable opportunities for higher education through scholarships and free ships and financial assistance to the needy students. Invoking the foregoing provision of the Higher Education Council Act, a unique Higher Education Scholarship Scheme was framed and launched in 2009. One thousand first year undergraduate students who pursue studies in science, humanities, social science, and business study streams in Government/Aided Colleges

and Universities of the State are selected for the scholarships every year. The scholarships of the awardees so selected would be renewed in the ensuing years till they complete their post graduation. Students pursuing professional courses are not eligible for Higher Education Scholarships of the Council.)

The Higher Education Scholarship Scheme is a continuing and regular programme introduced by the Council in 2009, for the benefit of students undergoing non-professional courses in Universities and govt./aided colleges in the state. It is a scholarship scheme primarily intended to attract excellent students to various disciplines in Basic Sciences, Human Sciences (Humanities & Social Sciences) and Business Studies.

The general feedback of the scheme received over the years from student community, parents and academic fraternity is encouraging. It is rated as one of the most popular scheme implemented in the higher education sector of our State during the last decade. On an average around 25,000 fresh undergraduate students apply for the Higher Education Scholarships of KSHEC every academic year. But, as the

number fresh scholarships for each academic year is limited to 1000, only around 4% of the applicants get the scholarships. Though the popular demand is to double the number of scholarships, the Council has decided to put forward a proposal to increase the number of fresh scholarships (for first year undergraduate studies) to 1200 from 1000.

## Administrative Report – 2017-18

Like 2016-17, the first half of 2017-18 was again a no- council period for KSHEC, since the Council was constituted only on 7th November, 2017. When the Vice Chairman and Member Secretary of the second Council vacated their respective offices on 11th April, 2016, the Registrar was delegated with nominal powers to carry out the day to day activities vide GO (Rt) No.1063/2016/H.Edn dtd. 12/04/2016. Ramankutty.C, Additional Secretary to the Government was the Registrar of the Council at the beginning of the financial year 2017-18 and he continued in the Council till 14/6/2017. On his transfer from the Council, Shri. Suresh Bau.A, Assistant Registrar held the charge of the Registrar for a short period. On 7/7/2017 Smt. Sherli.P, Additional Secretary to the Government assumed the office of the Registrar and continued in the capacity during the remaining days of 2017-18.

Shri. Manoj.S, Deputy Secretary to the Government, Finance Department who was working as the Finance Officer of KSHEC left the Council on 22/9/2017, on promotion as Joint Secretary. On 7/12/2017 Smt. Ajitha.K, Under Secretary to the Government took charge as the Finance Officer in his place.

Brainstorming session, written test and interview were held in May 2017 to fill the vacant Research Officer posts of the Council

and Shri. Shefiek, Dr. Manulal P Ram and Dr. Saji Mathew were inducted in the Council teams as ROs. Shri. Radhakrishnan.K, Shri. Sreejith and Shri. Manu Satheesh also joined the fold as Assistants on deputation basis during the year. In December, 2017 Smt. Deepika Lakshman was sanctioned deputation to the Council as Documentation Officer cum Librarian.

The Kerala State Higher Education Council, after a gap of around one and a half years, was reconstituted on 7th November, 2017 under the Vice Chairmanship of Dr. Rajan Gurukkal, former Vice Chancellor, MG University, Kottayam. Accordingly, Dr. Gurukkal and Dr. Rajan Varughese, the newly appointed Member Secretary assumed their respective offices on 9th November, 2017. Dr. Fathimathu Zuhra, Dr. Joy Job Kulavelil, Dr. J. Rajan, Dr. Suresh Kumar and Dr. K.K Damodaran are the five academicians nominated to the Executive Body of the Council as per clause 14 (d) of the Kerala State Higher Education Council Act. Dr. Latha, CUSAT is the Vice Chancellor nominated to the Executive Body for the initial year. *(EB of the Council is a 9 member body, chaired by the Vice Chairman. Member Secretary of the Council, Principal Secretary to the Government, Higher Education Department( Ex Officio), one Vice Chancellor nominated for a year and five academicians nominated under clause 14 (d) of the Act are its members).*

## Meetings of the Bodies of the Councils and Important Decisions

The first meeting of the Executive Body of the newly constituted Council was held on 29/11/2017 at the Board Room of KSHEC. Dr. Rajan Gurukkal chaired the meeting and all the members of the EB, except the Principal Secretary, Higher Education Department participated. Following are the important decisions taken by the first meeting of the EB:

- Constitution of a Committee under the headship of Dr. Joy Job Kulavelil to study the academic changes in autonomous colleges of the State. Dr. K.K Damodaran and Dr. J. Rajan are the other members of the committee.
- Constitution of a Committee under the headship of Dr. Fathimathu Zuhara for evolving implementation procedures to establish an Open University in the State on the basis of Kerala Open University (KOU) Report prepared by Dr. Ram Takwale. Dr. R.K Suresh Kumar is the other member of the Committee.
- Nominations were made to the Academic Councils of various universities under Section 17, Clause 'C' of the Kerala State Higher Education Council (Amendment) Ordinance 2017 as shown in the table given below.

The first meeting of the Governing Body of the newly constituted Council was held on 23/1/2018 at the Board Room of KSHEC. The meeting, which was chaired by the Hon'ble Minister for Education, took several important decisions including the following:

Approval of the 13th Five Year Plan Proposal of the Council and various programmes/schemes like integration of Brain Gain Concept to Erudite Scheme, University Level Quality Standardization and Teacher Training Programmes, Dhaishanik Paryavaran (Learner Ecosystem Campus), Prabudhata (Democratization of higher knowledge) and Academic Volunteer Bank (AVB).

- The meeting approved the proposal for the establishment of a permanent campus for KSHEC (Unnathi Bhavan)
- Approval of the revised guidelines of Cluster of Colleges scheme.
- Approval of the Annual Report, Audited Accounts and Audit Report of 2016-17 and KHHEC Budget of 2017-18.
- Approval of the proposal for creation of 9 new posts for KSHEC
- The GB decided to conduct a comprehensive annual survey of higher education in the state by KSHEC.
- The meeting resolved to authorize the Vice Chairman to constitute the following committees.
- To study the problems in filling up teaching in universities (Accordingly a 3 member committee was formed)

- To study the problems of Researchers in the State ( A 6 member committee has been formed under the chairmanship of Prof. ED Jemmis for this)
- To study the finances of the State Universities (A 3 member committee has been formed for this under the headship of Dr. B. Iqbal)
- Governing Body resolved to set up a Committee of Pro- Vice Chancellors to prepare the details related to formulation of a common academic and examination calendar for universities in the state and to monitor university examinations. It was also decided to examine the modalities to move from annual pattern of vacation (April- May) to split vacation ( November-May) in the universities/colleges
- Restructuring of PG Curriculum in Universities (A 6 member committee has been formed under the headship of Prof. E.D Jemmis)
- To study the problems of Inter-University Centres (IUC) (A 5 member committee has been formed for this under the headship of Dr. Rajan Gurukkal)

The Vice Chairman presented a few norms and common guidelines with respect to equivalency/ recognition related issues of degrees. The meeting accepted the norms and guidelines and resolved that KSHEC should formulate general guidelines for Equivalency/ Recognition Certificate by State Universities. (Accordingly a 10 member committee was formed under the chairmanship of Dr. Rajan Gurukkal for this)

The Second Executive Body meeting of the newly constituted Council was held on 20/2/2018 at the Board Room of KSHEC and the meeting expressed serious concern over the consequences of the UGC (conferment of autonomous status upon colleges and measures for maintenance of standards in autonomous colleges) Regulations, 2018 and resolved to appraise the Chairman of the Council, of the gravity of the issue. The

meeting also resolved to hold a two day National Seminar on Higher Education Policy Initiatives and Federal Principles of the Constitution.

During the year, the Council managed the financial and administrative matters of the three Member Commission constituted by the Government under the Chairmanship of Justice. K.K Denesan to enquire into the issues prevailing in self financing educational institutions.

### **Introduction of the New File Management System**

Shortage of staff, floating staff and flux of senior administrative officers have been persisting problems for the Council since its inception. To tide over the issues to the extent possible and to streamline the prevailing administrative procedure, a new file management system was introduced in the Council from 1st of January 2018 by the name Easy File Management System (EFMS)

Easy File Management System (EFMS), bearing the pet name easy-peasy, is a simple and straight forward file management system. The new file management system has been planned and designed as a solution to many of the administrative issues faced by the Council, including shortage of staff, multiplicity of files, increase of workload and floating staff.



**Objectives and Salient Features:** The objectives and salient features of EFMS are given below in bullet points.

- Simple & straight forward, but efficient, transparent and quick
- Basically a pragmatic way of doing things
- Aims to limit the number of files created every year
- Facilitates easy retrieval and keeping of files
- Subject-wise creation of files (one file/file number for a subject in a year)
- Pre-determined file number for each subject
- In consonance with budget heads and plan proposals
- List of files that would be operated in a calendar year is distributed to everybody concerned in advance (Hence transparent)
- Facilitates smart work
- Provides room to take up more work

When the newly file management system was appraised after two months of its introduction, it is understood that the administrative procedure of the Council has become more pragmatic, efficient, quick and transparent.

## Internal Committees

Internal Management Committee (IMC) and Internal Purchase cum Finance Committee are the two committees formed within the Council to facilitate decision making and implementation, on the basis of democratic discussions and opinion sharing.

Internal Management Committee is headed by the Vice Chairman himself and all the officers of the Council including the Member Secretary, Registrar, Finance Officer, Assistant Registrar and Research Officers are its members. Internal Purchase cum Finance Committee is chaired by the Member Secretary/ Registrar and Finance Officer, Assistant Registrar, Section

Officer, one of the Research Officers and Assistant (Accounts Section) are the members of the Committee. The committee makes recommendations to the Vice Chairman on purchase/ finance related matters.

The internal committees of the Council functioned quite efficiently during the reporting year. Besides the meetings of the aforesaid committees, Staff Meetings were also frequent during the

year and the democratic way of functioning created a cordial & healthy working atmosphere and warm interpersonal relationships.

## Audit Reports

The statutory auditor has given a clean report after auditing the accounts of the Council for the financial year 2017-18. Audit Party of the AG that conducted audit in the Council during September 2017 also couldn't point out any major irregularity.

The interpersonal relationship of the employees of KSHEC was cordial and warm during the period under report. The Council team continued the custom of celebrating festivals with great favour and mirth.

The Departments should also inform when such funds would be required. Hence the amount taken over by the government is not adjusted in utilization of grants instead is separately stated in the workings of unspent balance.

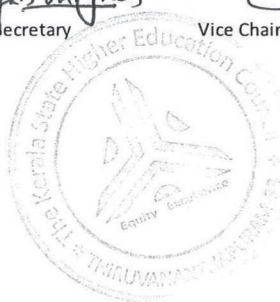

## **SIGNIFICANT ACCOUNTING POLICIES AND NOTES TO ACCOUNTS**

### **1. SIGNIFICANT ACCOUNTING POLICIES:-**

#### **A. ACCOUNTING CONVENTION:**

The financial statements are prepared on the basis of historical cost convention, unless otherwise stated, and on the accrual method of accounting followed by going concern concept, except for the Government Grants and other receipts except interest on investments.

#### **B. REVENUE RECOGNITION:**

Interest on investments is recognized on accrual basis on the basis if the statements from banks and estimates and interests on S.B Accounts and Grants from Government are taken on actual receipt basis as and when credited by bank. In certain cases where tax has been deducted on the interest paid the interest income has been accounted on accrual basis for matching the income with the income tax records.

#### **C. USE OF ESTIMATES**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, revenue and expenses. The estimates and assumptions used in the accompanying financial statements are based upon management's evaluation of the relevant facts and circumstances as of the date of the financial statements. Actual results may differ from the estimates and assumptions used in preparing the accompanying financial statements.

#### **D. FIXED ASSETS:**

- Fixed Assets of the centre are stated at historical cost less depreciation. The fixed assets acquired out of plan funds from Government of Kerala have been incorporated by credit of Capital Reserve Account.
- The balance of fixed asset represents historical cost less depreciation.

#### **E. DEPRECIATION**

- Depreciation on fixed assets has been charged under Written Down Value method by applying the rates specified under Income Tax Act 1961.

#### **F. GOVERNMENT GRANT**

The amount received from the government of Kerala through the Council is utilized for the purposes for which they were sanctioned. The amount after meeting the centre's capital and revenue expenses is represented by the unspent balance of Government Grant in the utilization certificate.



**G. UNSPENT BALANCE**

The balance of amount received after capital and revenue expenses in are stated in Utilisation certificate. The balances as stated in the accounts are on the basis of the classifications made in the previous years and the outstanding unspent balance under different heads may from the assumptions used in preparing the accompanying financial statements.

**H. CURRENT ASSETS**

- Cash and bank balances represent the balances with the Treasury account and savings bank account.
- Cash equivalents like fixed deposits are as per the confirmations provided.

**I. LOANS AND ADVANCES.**

- Advances and deposits with the suppliers and creditors are as certified by the management and are considered good.

**J. INCOME AND EXPENDITURE ACCOUNT**

Income and expenses of the center other than grant from government and other receipts except interest on investments are accounted on accrual basis unless otherwise stated elsewhere. The institute is implementing projects under the following categories namely, Higher Education Scholarship, Higher Education Scholarship Renewal, Programmes Under Center for Research on Policies in Higher Education, Programmes Under Center for Human Resources Development & Capacity Building, Manapuram Endowment Scheme, Project Financing, Additional assistance to 3 Clusters and Students & Teacher Exchange Programme.

**ACT 22 OF 2007****THE KERALA STATE HIGHER EDUCATION COUNCIL ACT, 2007****An act to provide for the setting up of the Kerala State Higher Education Council**

Preamble.- WHEREAS, it is expedient to establish a State Higher Education Council as a collective of the Government, Universities, academics, experts and people's representatives in order to forge a synergic relationship among them by occupying an operational space in between the Government and Universities and between Universities and apex level regulatory bodies, with the objects of (i) ensuring the autonomy and accountability of all institutions of higher education in the State, (ii)-promoting academic excellence and social justice by providing academic input to the State Government for policy formulation and perspective planning, and (iii) guiding the growth of higher education in accordance with the socio-economic requirements of the State;

AND WHEREAS it is necessary to achieve the above said objectives to empower this Council to (i) review and coordinate the implementation of policies in all higher education institutions in the State including Universities, research institutions and colleges, (ii) network various programmes in higher education undertaken and promoted by the Central and State Governments and by national level regulatory bodies including the University Grants Commission, All India Council for Technical Education, National Council for Teacher Education, Medical Council of India, Bar Council of India and other similar statutory bodies, (iii) undertake independent work for the generation and dissemination of new ideas in higher education, (iv) provide common facilities for all Universities, research institutions, colleges and other centres of higher education, (v) provide for the generation and optimum utilization of funds for the expansion and development of higher education and (vi) undertake such other programmes for promoting the objectives of social justice and excellence in education ;

**BE it enacted in the Fifty-eighth Year of the Republic of India, as follows:-**

**1. Short title, Extent and Commencement.**

- (1) This Act may be called the Kerala State Higher Education Council Act, 2007.
- (2) It extends to the whole of the State of Kerala.
- (3) It shall be deemed to have come into force on 25th January, 2007.

**2. Definitions. — In this Act, unless the context otherwise requires,-**

- (a) "Advisory Council" means the Advisory Council of the Council;
- (b) "All India Council for Technical Education" means the Council constituted under the All India Council for Technical Education Act, 1987 (Central Act 52 of 1987);

- (c) "Bar Council of India" means the Bar Council constituted under the Advocates Act, 1961 (Central Act 25 of 1961);
- (d) "Chairman" means the Chairman of the Council;
- (e) "college" means any Higher Education Institution affiliated to a University;
- (f) "Council" means the Kerala State Higher Education Council constituted under section 3;
- (g) "Executive Council" means the Executive Council of the Council;
- (h) "Governing Council" means the Governing Council of the Council;
- (i) "Government" means the Government of Kerala;
- (j) "Higher education" means the education and research studies leading to the award of a degree or diploma or certificate by a University or an institution approved by a University;
- (k) "Institution" means an academic institution of higher education and research, not being a college, associated with and admitted to privileges of a University or maintained by a University;
- (l) "Medical Council of India" means the Council constituted under the Indian Medical Council Act, 1956 (Central Act 102 of 1956);
- (m) "Member" means a member of the Advisory Council, the Governing Council or the Executive Council, as the case may be;
- (n) "National Council for Teacher Education" means the Council constituted under the National Council for Teacher Education Act, 1993 (Central Act 73 of 1993);
- (o) "Notification" means the notification published in the official Gazette;
- (p) "Patron" means the Patron of the Council;
- (q) "Prescribed" means prescribed by rules made under this Act;
- (r) "Regular student" means a regular student of a university or a college affiliated to a university;
- (s) "Regulations" means the regulations made by the Governing Council under this Act;
- (t) "State" means the State of Kerala;



- (u) "Statutes", "Ordinances" and "Regulations" of a University means respectively, the Statutes, the Ordinances and the Regulations issued under the respective Acts of a University;
- (v) "Teacher" means any regular teacher working in a University, Government College or Government aided College or institution whose appointment has been made by a University or Government or approved by a University;
- (w) "University" means any University in the State established by an Act of the State Legislature;
- (x) "University Grants Commission" means the Commission established under the University Grants Commission Act, 1956 (Central Act 3 of 1956);
- (y) "Vice-Chairman" means the Vice-Chairman of the Council;
- (z) "Visitor" means the Visitor of the Council.

### **3. Constitution of the Council.**

- (1) The Government may by notification, constitute, with effect from such date as may be specified therein, a Council to be called the Kerala State Higher Education Council.
- (2) The Council shall be a body corporate by the name aforesaid, having perpetual succession and a common seal and shall by the said name sue and be sued.
- (3) The headquarters of the Council shall be at Thiruvananthapuram.

### **4. Responsibilities and functions of the Council.-**

- (1) The Council shall have the following general responsibilities and functions, namely:-
  - (a) to render advice to the Government, Universities and other institutions of higher education in the State;
  - (b) to co-ordinate the roles of the Government, Universities and apex regulatory agencies in higher education within the State;
  - (c) to evolve new concepts and programmes in higher education;
  - (d) to provide common facilities in higher education without impinging upon the autonomy of other institutions of higher education.
- (2) For the furtherance of the above responsibilities and functions, the Council shall specifically undertake the following, namely:-
  - (a) provide academic input to the Government and to the Universities, research institutions and other centers of higher education in the State for the formulation and implementation of the policies on higher education and evolve a perspective

- plan for the development of higher education, suo moto or on the suggestion from Government or requests from Universities or other institutions;
- (b) undertake independent research for the generation of new ideas for the promotion of social justice and academic excellence in higher education hold awareness programmes for the academia and initiate or propose or pilot projects on an experimental basis in selected higher education institutions for implementation of the new ideas;
  - (c) undertake human resources development planning for the State and plan the growth and development of higher education in accordance with such planning;
  - (d) evolve guidelines for linkages of an academic nature among higher-education institutions in the State and institutions within and outside the country;
  - (e) evolve programmes in order to promote the relevance of higher education for the economic, social and cultural development of the State;
  - (f) review existing guidelines and furnish recommendations for regulating admissions to various courses and for appointments to the posts of teachers and teacher-administrators in Universities, colleges and other institutions of higher education;
  - (g) suggest improvements in curriculum and syllabi in accordance with the changing societal and academic requirements and facilitate the development and publication of appropriate teaching material, including textbooks, educational softwares and e-learning facilities in order to improve the quality of education;
  - (h) organise short term courses to train and update the knowledge and skills of higher education teaching personnel, educational administrators and other similarly situated;
  - (i) advise the Government on the starting of new courses, colleges, and other higher education institutions in the State;
  - (j) make proposals for the generation and utilisation of funds in accordance with the objectives of this Act;
  - (k) evolve general guidelines for the release of grants by the Government to Universities and other institutions of higher education and advise the Government about the release of such grants to Universities and other institutions of higher education;
  - (I) evolve schemes for providing equitable opportunities for higher education and scholarships and freeships and financial assistance to the needy students and coordinate implementation of Scheduled Castes and Scheduled Tribes and other Eligible Backward Classes welfare programmes of the Central and the State Governments and other Central and State Level Funding Agencies;

- (m) review periodically the Statutes, Ordinances and Regulations of the Universities in the State and suggest appropriate improvements for the realisation of the objectives of social justice and academic excellence in education and suggest the framework for new Statutes, Ordinances, or Regulations for existing Universities or other institutions of higher education ‘ or new Universities or other institutions of higher education;
- (n) provide common facilities for the entire State by establishing centres, namely:-
  - (i) Centre for Research on Policies in Higher Education;
  - (ii) Curriculum Development Centre;
  - (iii) Centre for Capacity Building in respect of faculty and educational administrators;
  - (iv) State Council for Assessment of Higher Education Institutions;
  - (v) Examination Reforms Cell;
  - (vi) Human Resources Development, Employment and Global Skills Development Cell.
- (o) hold discussions, conduct workshops and seminars with the objective of facilitating the widest possible consultations with experts and stakeholders including organizations of students and teachers for formulating the policies on higher education and facilitating their proper implementation;
- (p) facilitate the development of a synergic relationship among different agencies such as the State Government, Universities, colleges and other institutions of higher education in the State and the Central Government and regulatory bodies at the national level;
- (q) co-ordinate various programmes being promoted and undertaken by Central and State Governments and national level bodies like University Grants Commission, All India Council for Technical Education, National Council for Teacher Education, Medical Council of India, Bar Council of India and other similar statutory bodies and State level institutions like Universities, research institutions, colleges and other institutions of higher education in the territory of India;
- (r) provide a forum for the interaction among the academy, industries, agriculture and service sectors;
- (s) facilitate the conduct of workshops and seminars on questions of importance in higher education in different parts of the State;
- (t) undertake necessary steps for establishing inter-linkages between research and learning processes;

- (u) promote extension activities in colleges, institutions and Universities and encourage their integration into the curriculum so that the students and teachers become sensitive to social issues;
- (v) promote sports and cultural activities in the colleges, other institutions and Universities and integrate them with the co-curricular activities;
- (w) perform such other functions for the realisation of the twin objectives of social justice and excellence in higher education;
- (x) suggest steps for promoting democratisation and academic autonomy of Universities and other institutions of higher education;
- (y) evolve schemes to sensitise the students to environmental and gender issues.

#### **5. The Patron.-**

- (1) The Governor of Kerala, by virtue of his office shall be the Patron of the Council.
- (2) The Patron shall have the right to call for report on any matter pertaining to the affairs of the Council and offer suggestions for the improvement of the functioning of the Council.
- (3) The Patron, shall have the right to address any meeting of the Council, if he/she so desires.

#### **6. The Visitor.-**

- (1) The Chief Minister of Kerala shall, by virtue of his office, be the Visitor of the Council.
- (2) The Visitor shall have the right to call for report on any matter pertaining to the affairs of the Council and offer suggestions for the improvement of the functioning of the Council.
- (3) The Visitor, shall preside over the meeting of the Advisory Council.

#### **7. The Chairman.-**

- (1) The Minister in charge of Higher Education of the State shall, by virtue of his office, be the Chairman of the Council.
- (2) The Chairman shall have the right to call for report on any matter pertaining to the affairs of the Council and offer suggestions for the improvement of the functioning of the Council.
- (3) The Chairman shall preside over the meetings of the Governing Council and shall preside over the meetings of the Advisory Council in the absence of the Visitor.

**8. The Vice-Chairman.-**

- (1) An eminent educationalist, preferably a former Vice-Chancellor, shall be appointed by the Government as the Vice-Chairman of the Council.
- (2) The Vice-Chairman shall be the executive head of the Council.
- (3) The Vice-Chairman shall preside over the meetings of the Executive Council and shall preside over the meetings of the Advisory Council and the Governing Council in the absence of the Visitor and the Chairman, as the case may be.
- (4) The Vice-Chairman shall exercise such other powers and perform such other functions as may be prescribed.

**9. The Member-Secretary.-**

- (1) An academician, preferably with administrative experience, shall be appointed by the Government as Member-Secretary of the Council.
- (2) The Member-Secretary shall be responsible for the co-ordination of the academic functions of the Council.
- (3) The Member Secretary shall exercise such powers and perform such other functions as may be prescribed.

**10. The Registrar.-**

- (1) An officer not below the rank of a Joint Secretary to Government shall be appointed by the Government as Registrar of the Council on deputation.
- (2) The Registrar shall be responsible for the administration of the office of the Council.
- (3) The Registrar shall represent the Council in all suits and other legal proceedings for and against the Council.
- (4) The Registrar, shall exercise such other powers and perform such other functions as may be prescribed.
- (5) The terms and conditions of service of the Registrar shall be such as may be prescribed.

**11. Composition of the Council.—**

- (1) The Council shall comprise of the following bodies, namely:-
  - (a) the Advisory Council;
  - (b) the Governing Council;
  - (c) the Executive Council;
- (2) The bodies of the Council shall be reconstituted every four years from the date of their constitution: provided that in the event of delay in the re-constitution of the bodies, they

shall continue to be in office for a further period of six months or till their reconstitution, which ever is earlier.

## 12. The Advisory Council.-

The Advisory Council shall consist of the following members, namely:-

- (a) the Visitor;
- (b) the Chairman;
- (c) the Leader of Opposition in the Assembly;
- (d) the Minister for Health and Family Welfare;
- (e) the Minister for Agriculture;
- (f) the Minister for Law;
- (g) the Vice-Chairman;
- (h) the Member-Secretary;
- (i) two members of the Parliament from the State, one from the Lok Sabha and the other from the Rajya Sabha, nominated by the Government;
- (j) five members of the Legislative Assembly of Kerala, of whom one shall be a member of the Scheduled Caste or Scheduled Tribe and one shall be a woman, nominated by the Speaker;
- (k) one Vice-Chancellor of a University outside the State, nominated by the Government;
- (l) the Vice-Chairman, State Planning Board;
- (m) the Chairperson, Women's Commission;
- (n) the Chief Secretary to Government;
- (o) a prominent industrialist or business man, nominated by the Government;
- (p) an eminent person from the field of arts or literature, nominated by the Government;
- (q) an eminent social scientist nominated by the Government;
- (r) an eminent person from print or visual media, nominated by the Government;
- (s) an eminent member from the medical profession, nominated by the Government;
- (t) an eminent sports person, nominated by the Government;
- (u) an eminent scientist or technologist, nominated by the Government;
- (v) an eminent agriculturist, nominated by the Government;
- (w) an eminent jurist, nominated by the Government;



- (x) one Grama Panchayat President, nominated by the Government;
- (y) one Block Panchayat President, nominated by the Government;
- (z) one District Panchayat President, nominated by the Government;
- (aa) one Municipal Chairperson, nominated by the Government-
- (ab) one Mayor, nominated by the Government.

### **13. Powers and Functions of the Advisory Council.-**

The Advisory Council shall meet at least once a year and shall deliberate on the general policies in higher education with particular reference to the functioning of the Council.

### **14. The Governing Council.-**

The Governing Council shall consist of the following members, namely: -

- (a) the Chairman;
- (b) the Vice-Chairman;
- (c) the Member-Secretary;
- (d) five educationalists of repute from different Academic disciplines, of whom one shall be a woman and one belonging to Scheduled Caste or Scheduled Tribe, nominated by the Government;
- (e) the Vice-Chancellors of all Universities;
- (f) a teacher member of the Academic Council of each University elected by the respective Academic Council of the University;
- (g) two student representatives of the University Unions or two regular students, of whom one shall be a woman, nominated by the Government;
- (h) a person who has distinguished himself in extension activities, nominated by the Government;
- (i) the Director of a Research Institution, nominated by the Government;
- (j) the member of the State. Planning Board in charge of education;
- (k) a nominee of the University Grants Commission not below the rank of Joint Secretary, Ex- officio;
- (l) the Secretary to Government, Higher Education Department, Ex-officio;
- (m) the Secretary to Government, Finance Department, Ex-officio;
- (n) the Director of Technical Education, Ex-officio;
- (o) the Director of Medical Education, Ex-officio;

- (p) the Executive Vice-President, Kerala State Council for Science, Technology and Environment, Ex-officio;
- (q) the Director of Collegiate Education, Ex-officio;
- (r) the Agricultural Production Commissioner, Ex-officio. ‘

**15. Powers and functions of the Governing Council.—The Governing Council shall have the following powers and functions, namely: -**

- (a) it shall take all policy decisions on behalf of the Council;
- (b) it shall chalk out a perspective plan for the implementation of the policies, evolve various programmes to be implemented and determine the priorities of such programmes for implementation;
- (c) it shall approve the annual budget and the audited statement of expenditure in such manner as may be prescribed;
- (d) it shall make a self-appraisal of its performance and prepare an annual report showing details of its academic performance;
- (e) it shall give such directions to the Executive Council as may be necessary for the effective functioning of the Council in accordance with its objectives;
- (f) it shall with prior approval of the Government frame regulations in accordance with this Act and the rules made thereunder;
- (g) It shall propose general guidelines for the release of grants by the Government to Universities and other institutions of higher education and advise the Government about the release of such grants to each University and other institutions of higher education;
- (h) it shall suggest measures for the academic and financial accountability of the Universities and other Institutions of higher education in the State;
- (i) it shall advise the Government and Universities and other institutions of higher education regarding the procedure of implementation of its decisions in all institutions of higher education;
- (j) it shall have such other powers as may be prescribed for the effective implementation of the programmes for the furtherance of the objectives of this Act;
- (k) it shall meet, as often as may be necessary, at such time and place and observe such rules of procedure as may be provided in the regulations provided that it shall meet at least twice a year;
- (l) it shall have power to act, notwithstanding any vacancy in the membership or any defect in the constitution thereof, and the proceedings of the Governing

Council shall be valid notwithstanding that some person, who was not entitled to be a member, had attended, or otherwise had taken part in the proceedings of the Governing Council.

#### **16. The Executive Council.-**

There shall be an Executive Council for the Council consisting of the following members of the Governing Council, namely:-

- (a) the Vice-Chairman;
- (b) the Member-Secretary;
- (c) one of the Vice-Chancellors, nominated by rotation by the Government for a period of one year;
- (d) five educationalists nominated under clause of section 14.
- (e) the Secretary to Government, Higher Education Department, Ex-officio.

#### **17. Powers and duties of the Executive Council.-**

The Executive Council shall have the following powers and duties, namely: -

- (a) it shall be competent to take decisions on behalf of the Council, subject to the concurrence of the Governing Council in all matters with policy implications: Provided that in urgent circumstances instead of concurrence, subsequent ratification of the Governing Council shall be sufficient;
- (b) it shall incur such expenses as are necessary to fulfill the objectives set out in this Act and carry out all decisions taken by the Governing Council;
- (c) it shall nominate one of its members to the Syndicate/Executive Committee of each University and such member shall ensure effective communication of the views of the Council and co-ordinate the implementation of programmes common to all universities;
- (d) it shall present before the Advisory Council the annual academic and financial audit reports of the Council for its perusal;
- (e) it shall present before the Governing Council the annual academic and financial audit reports of the Council for its approval;
- (f) it shall have such other powers, functions and duties as may be prescribed.

#### **18. Special Invitees.-**

- (1) The Vice-Chairman of the Council may for the purpose of carrying out the objectives of this Act, invite in writing any person who is not a member of the Council to take part in the deliberations of particular meetings of the Advisory Council, Governing Council and

Executive Council and any other Body constituted by the Council for specific purposes as special invitees and such invitees shall have no right to vote in the meetings.

- (2) The special invitees shall be paid from and out of the funds of the Council such sums as may be approved by the Vice-Chairman.

### **19. Meetings.-**

- (1) The meetings of the Advisory Council, the Governing Council and the Executive Council shall be convened by the Member-Secretary on the advice of the Vice- Chairman.
- (2) The quorum for the meetings of the Governing Council and the Executive Council shall be one third of filled up membership in each body and decisions may be taken in the meetings by simple majority of those present and voting. There shall be no quorum for the meetings of the Advisory Council and decisions may be taken in the meetings by simple majority of those present and voting.

### **20. Terms and Conditions of the Vice Chairman, Member Secretary and Members.-**

- (1) The Vice Chairman, Member Secretary and Members other than the Member of the Executive Council nominated under clause (c) of Section 16, unless removed from the office in accordance with the provisions of this Act, shall hold office for entire term of the Body of Council to which they are appointed or nominated or elected as the case may be; provided that they shall continue to hold office of Vice Chairman, Member Secretary and Members respectively for a further period of six months or till further appointment or nomination or election is made to the respective offices, whichever is earlier; provided further that Vice Chairman, Member Secretary and the Members shall be eligible for re-appointment or re-nomination or re - election for a further term of four years, as the case may be.
- (2) The Vice-Chairman, Member-Secretary or Members, may in writing under his signature, addressed to the Chairman, resign his membership from the Council: Provided that he shall continue to hold such office until his resignation is accepted and communicated in writing.
- (3) The salaries, allowances and other perquisites payable to the Vice-Chairman shall be the same as that of Vice-Chancellor of a University and that payable to the Member Secretary shall be the same as that of a Pro-Vice Chancellor of a University.
- (4) Subject to the provisions of this section, the other terms and conditions of service of the Vice-Chairman, Member Secretary and Members shall be such as may be prescribed.

### **21. Removal from Membership of the Council.-**

If, at any time, it appears to the Government that a member appointed or nominated or

elected Member has proved himself to be unfit to hold such office or has been guilty of misconduct or neglect which in the opinion of the Government renders his removal from the membership of the Council, as expedient, the Government may, after giving such member, a reasonable opportunity of showing cause as to why he shall not be removed from the Council and after examining the same decide whether to continue or remove such member, as the case may be, from his membership and in case of such removal from the membership of the Council it shall be made by notification.

## **22. Filling up of casual vacancy.-**

If a casual vacancy arises in the office of a nominated or appointed Member, either by reason of his death, resignation, removal or otherwise, such vacancy shall be filled up by the Government by nomination or appointment and such Member shall hold office only for the remainder of the term of the Member in whose place he was nominated or appointed, as the case may be.

## **23. Protection of acts done in good faith.-**

No suit, prosecution or other legal proceeding shall lie against the Council or any member or officer or employee of the Council for anything which is done or intended to be done in good faith in pursuance of the provisions of this Act or any rules or regulations made thereunder.

## **24. Staff of the Council.-**

The Council shall, with prior approval of the Government appoint such officers and staff, as it deems necessary for the discharge of its functions under this Act. The terms and conditions of service of the officers and staff of the Council shall be such as may be specified in the regulations to be framed by the Council.

## **25. Funds of the Council.-**

- (1) The funds of the Council shall include all sums which may, from time to time, be paid to it by the Government and all other receipts including any sum from the Central Government, any State Government, the University Grants Commission or any other authority, institutions or person.
- (2) The Government may pay to the Council every financial year such sums as may be considered necessary for the functioning of the Council and for the discharge of its responsibilities and duties.
- (3) All expenditure incurred by the Council under or for the purposes of this Act shall be

defrayed from out of the Fund and any surplus remaining, after such expenditure has been met, shall be invested in such manner as may be prescribed.

## **26. Annual Accounts and Audit.-**

- (1) The accounts of the Council shall be maintained in such manner and in such form as may be prescribed
- (2) The Council shall prepare an annual statement of accounts in such form and in such manner as may be prescribed.
- (3) The accounts of the Council shall be audited once in a year by such auditor as the Government may appoint in this behalf.
- (4) The auditor appointed under sub-section (3) shall, for the purposes of audit, have such rights, privileges and authority as may be prescribed.
- (5) The Member-Secretary to the Council shall cause the annual audit report to be printed and forward a printed copy thereof to each member and shall place such report before the Governing Council for consideration at its next meeting.
- (6) The Governing Council shall take appropriate action forthwith to remedy any defect or irregularity that may be pointed out in the audit report.
- (7) The accounts of the Council as certified by the auditor together with the audit report along with the remarks of the Governing Council thereon shall be forwarded to the Government within such time as may be prescribed.
- (8) The Government shall, as soon as may be after the receipt of the annual accounts together with the audit report under sub-section(7), cause the same to be laid before the Legislative Assembly.

## **27. Annual Report. –**

- (1) The Council shall prepare for every year a report or its activities under this Act during that year and submit the report to the Government in such form as may be prescribed.
- (2) The Government shall, as soon as may be after the receipt of a report under sub-section (1), cause the same to be laid before the Legislative Assembly.

## **28. Members and Staff of the Council to be public servants. –**

The Chairman, Vice-Chairman, Members, Officers and Staff of the Council shall be deemed, when acting or purporting to act in pursuance of any of the provisions of this Act or any rule or regulation or order or direction made or issued under this Act shall be deemed to be public servants within the meaning of section 21 of the Indian Penal Code (Central Act 45 of 1860).



### **29. Overriding effect of the Act.-**

The provisions of this Act or any rule made thereunder shall have effect notwithstanding anything inconsistent therewith contained in any law, other than this Act or in any instrument having effect by virtue of any law other than this Act or in any decree or order of any court or other authority.

### **30. Power to make regulations:-**

- (1) The Governing Council may with the prior approval of the Government frame regulations in accordance with this Act and Rules made thereunder for carrying out all or any of the purposes of this Act.

### **31. Power to make rules.-**

- (1) The Government may by notification make rules either prospectively or retrospectively, for carrying out all or any of the purposes of this Act.
- (2) Every rule made under this Act shall be laid, as soon as may be after it is made, before the Legislative Assembly, while it is in session for a total period of fourteen days which may be comprised in one session or in two successive sessions, and if, before the expiry of the session in which it is so laid or the session immediately following, the Legislative Assembly makes any amendment in the rule or decides that the rule should not be made the rule shall, thereafter, have effect only in such form as amended or be of no effect, as the case may be; so, however, that any such amendment or annulment shall be without prejudice to the validity of anything previously done under that rule.

### **32. Power to remove difficulties.-**

- (1) If any difficulty arises in giving effect to the provisions of this Act, the Government may, by order, as occasion may require, do anything not inconsistent with the provisions of this Act which appears to them to be necessary or expedient for the purpose of removing the difficulty.
- (2) Every order issued under sub-section (1) shall, as soon as may be after it is made be laid before the Legislative Assembly.

### **33. Repeal and Saving.-**

- (1) The Kerala State Higher Education Council Ordinance, 2007 (49 of 2007) is hereby repealed.
- (2) Notwithstanding such repeal, anything done or deemed to have been done or any action taken or deemed to have been taken under the said Ordinance, shall be deemed to have been done or taken under this Act.



**ACT 19 OF 2018**  
**THE KERALA STATE HIGHER EDUCATION COUNCIL**  
**(AMENDMENT) ACT, 2018**

**An act to amend the Kerala State Higher Education Council Act, 2007**

Preamble. – WHEREAS, it is expedient to amend the Kerala State Higher Education Council Act, 2007, for the purposes hereinafter appearing;

**BE it enacted in the Sixty- ninth Year of the Republic of India as follows:-**

1. Short title and commencement.- (1) This act may be called the Kerala State Higher Education Council (Amendment) Act, 2018. (2) It shall be deemed to have come into force on the 5th day of July 2017.
2. Amendment of the preamble.-In the Kerala State Higher Education Council Act, 2007 (22 of 2007) (hereinafter referred to as the principal Act), in the preamble, in the first paragraph, for the word “experts”, the words and symbols “experts, teachers, students “ shall be substituted.
3. Substitution of certain expressions by certain other expressions.- In the principal Act, for the words “Advisory Council”, “Executive Council” and “Governing Council”, wherever they occur, the words “Advisory Body”, “ Executive Body” and “Governing Body” shall, respectively, be substituted.
4. Amendment of section 2.- In section of 2 of the principal Act, after clause (s), the following clause shall be inserted, namely:-  
“(sa) “RUSA” means the Rashtriya Uchchatar Sahiksha Abhiyan, a centrally sponsored scheme for higher education;”.
5. Amendment of Section 4.- In section 4 of the principal Act,-
  - (i) In sub-section (1), for clause (a), the following clause shall be substituted, namely:-  
“(a) to render advice to the Government, Universities, colleges and other institutions of higher education in the State in matters of access, equity and excellence in higher education;”
  - (ii) in sub-section (2) after clause (y), the following clauses shall be inserted, namely:-  
“(z) conduct longitudinal studies to understand the impact of student learning;  
(Za) promote and integrate scientifically proven indigenous knowledge systems in the State higher education system;

- (zb) evolve programmes to improve access to higher education for differently abled students;
  - (zc) collaborate with the Government in the implementation of RUSA and other similar centrally sponsored schemes and other central sector schemes within the State;
  - (zd) evolve common academic guidelines for Universities in the State for mutual recognition, approval or equalization of academic programmes or areas of studies and nomenclature thereof ;
  - (ze) evolve common academic guideline for Universities in the State for recognition, approval or equalization of academic programmes or areas of studies and nomenclature thereof of various programmes conducted or co-ordinated by Universities or higher education institutions outside the State and outside the country;
  - (zf) facilitate the dissemination of knowledge of higher education to target audience through electronic and print media.”
6. Amendment of section 5.- In section 5 of the principal Act, after sub-section (3), the following sub-section shall be inserted, namely:-
- “(4) The Patron may refer any matter relating to higher education and higher education institutions as he deems fit, for the expert opinion of the Council.”
7. Amendment of section 6. – In section 6 of the principal Act, after sub-section (3) the following sub-section shall be inserted, namely:-
- “(4) The Visitor may refer any matter relating to higher education and higher education institutions, as he deems fit, for the expert opinion of the Council.”
8. Amendment of section 9.- In section 9 of the principal Act, in sub-section (3), after the words “ as may be prescribed”, the words, “or delegated by the Vice- Chairman from time to time” shall be inserted .
9. Amendment of section 10.- In section 10 of the principal Act, in sub-section (4) , after the words “as may be prescribed”, the words “or delegated by the Vice- Chairman from time to time” shall be inserted.
10. Amendment of section 11.- In section 11 of the principal Act in sub-section (2),-
- (i) after the words “shall be reconstituted” , the word “simultaneously” shall be inserted;
  - (ii) in the proviso, for the words, “shall continue to be in office for a further period of six months or till their reconstitution, whichever is earlier”, the words “shall continue to hold office till their reconstitution” shall be substituted.

11. Amendment of section 12.- In section 12 of the Principal Act.-
  - (i) for item (k) the following item shall be substituted, namely:-  
 “(k) one Vice- Chancellor of a University outside the State of Kerala established by an Act of another State, nominated by the Government;”
  - (ii) after item (ab), the following items shall be inserted, namely:-  
 “(ac) one Chairman or Vice-Chairman of a State Higher Education Council outside the State of Kerala, nominated by the Government:  
 (ad) one Vice- Chancellor of a Central University outside the State, nominated by the Government.”.
12. Amendment of section 14.- In section 14 of the principal Act, after item (r), the following items shall be inserted, namely:-
  - “(s) one nominee of the Ministry of Human Resources Development, Government of India, not below the rank of a Joint Secretary;
  - (t) State Project Director, RUSA;
  - (u) one Principal of an affiliated college, nominated by the Government;
  - (v) one non-teaching staff member of a University or College, nominated by the Government,”.
13. Amendment of section 15.- In section 15 of the principal Act, in clause (k),-
  - (i) after the words “it shall meet”, the words “at least twice a year and” shall be inserted;
  - (ii) the words “provided that it shall meet at least twice a year” shall be omitted.
14. Amendment of section 17.- In section 17 of the principal Act, for clause (c), the following clause shall be substituted, namely:-  
 “(c) it shall nominate one of its members to the Academic Council of each University”.
15. Amendment of section 20.- In section 20 of the principal Act, in sub- section (1) in the first proviso, the words, “for a further period of six months or” and the words “whichever is earlier” shall be omitted.
16. Amendment of section 25.- In section 25 of the principal Act, in sub - section (1), after the words “the University Grants Commission”. the symbol and word, “RUSA” shall be inserted.
17. Special provision relating to existing Governing Council.-  
 Notwithstanding anything contained in the principal Act, on and from the date of commencement of the Kerala State Higher Education Council (Amendment) Ordinance,

2017 (13 of 2017), the existing Governing Council shall stand dissolved and all the members of the said Governing Council shall be deemed to have vacated their offices as such on such dissolution.

18. Repeal and saving.- (1) The Kerala State Higher Education Council (Amendment) Ordinance, 2018 (26 of 2018) is hereby repealed.
- (2) Notwithstanding such repeal, anything done or deemed to have been done or any action taken or deemed to have been taken under the Principal Act as amended by the said Ordinance shall be deemed to have been done or taken under the principal Act as amended by this Act.
